The *Reunited Brittany* Association is member of the Platform of the European Union Fundamental Rights Agency. It gathers 48 cultural associations, business companies, civil society actors and individual members (about 800). 5,000 elected representatives in the whole Brittany have signed the Charter proposed for reunification of Brittany.

Social Purpose: Recognition as a territorial collectivity of the Brittany region, formed by the five departments of Côtes-d'Armor, Finistère, Ille-et-Vilaine, Loire-Atlantique and Morbihan. (Art. 1 of Status).

The *Breton Collective for Democracy and Human Rights* is not a political party but a gathering of citizens who work for the emergence of these majority aspirations but which are deliberately ignored. The association works in the cultural, historical, political, and administrative field and matters, in a citizenship approach.

***The five points highlighted in October 1999***, still relevant and essential bases of a true democratization of Breton society:

- 1 Adapt the French Constitution in compliance with European and international standards;
- 2. Get a Regional public educational status for *Diwan* (Breton teaching school by immersion) and for the Breton language, its teaching being properly insured within the three networks : *Div Yezh* (“Two languages”, public), *Dihun* (“Awakening”, private) and *Diwan* (“germ-seed”, association), and similarly for Gallo language (originally spoken in the Eastern part of Brittany);
- 3. Reinstatement of the Loire-Atlantique within Brittany, politically and administratively;
- 4. Give Brittany a genuine regional power with skills and financial resources equal to the other European regions;
- 5. Provide economic measures in the respect of human beings and environment in front of the globalization of markets.
